7 **A Resolution authorizing the County Executive to advertise for bids for one twenty bed**  
8 **mobile hospital with one trailer for equipment storage and transport, in an amount not to**  
9 **exceed \$210,339.31, for the Executive's Department of Law, Insurance, and Risk**  
10 **Management-Division of Public Safety- Division of Emergency Management, and declaring**  
11 **an emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
14 requires this Council's authorization for the County Executive to advertise for bids; and

15  
16 WHEREAS, the County Executive wishes to advertise for one twenty bed mobile  
17 hospital with one trailer for equipment storage and transport, in an amount not to exceed  
18 \$210,339.31; and

19  
20 WHEREAS this Council finds and determines, after reviewing all pertinent information  
21 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
22 advertise for bids for the aforementioned mobile hospital bed;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
25 of Ohio, that:

27 SECTION 1

29 The County Executive is authorized to advertise for bids for one twenty bed mobile  
30 hospital with one trailer for equipment storage and transport to help provide alternate care sites  
31 during a chemical, biological, radiological, nuclear, or explosive terrorist incident or pandemic,  
32 in an amount not to exceed \$210,339.31.

34 SECTION 2

35  
36 This Resolution is hereby declared an emergency in the interest of the health, safety and  
37 welfare of the citizens of the County of Summit, and for the further reason that it authorizes the  
38 Executive to immediately advertise for bids for one twenty bed mobile hospital with one trailer  
39 for equipment storage and transport.

41 SECTION 3

42  
43 Provided this Resolution receives the affirmative vote of eight members, it shall take  
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
45 effect and be in force at the earliest time provided by law.

47 SECTION 4

49 It is found and determined that all formal actions of this Council concerning and relating  
50 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
51 deliberations of this Council and of any of its committees that resulted in such formal action,  
52 were in meetings open to the public, in compliance with all legal requirements, including Section  
53 121.22 of the Ohio Revised Code.
