7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Oriana House, Inc. for community corrections services for a one-year term,**
9 **from 1/1/17 through 12/31/17, in an amount not to exceed \$5,921,097.39, with four options**
10 **to renew for an additional one-year term, with the cost of any renewal term to be equal to**
11 **the increase in the Consumer Price Index or three percent (3%), whichever is less, over the**
12 **previous term, for the Executive's Department of Law, Insurance and Risk Management-**
13 **Division of Public Safety and declaring an emergency.**

15 WHEREAS, on September 12, 2016, the County of Summit solicited five providers of
16 community corrections programs and advertised Requests for Proposals to provide day reporting,
17 driver intervention, home incarceration, multiple offender and residential community corrections
18 services; and

20 WHEREAS, on the deadline of October 10, 2016, Oriana House, Inc. was the only
21 provider to submit a proposal; and

23 WHEREAS, the Board of Control, at its meeting held November 9, 2016, awarded a
24 professional service contract with Oriana House, Inc. for community corrections services for a
25 one-year term, from 1/1/17 through 12/31/17, in an amount not to exceed \$5,921,097.39, with
26 four options to renew for an additional one-year term, with the cost of any renewal term to be
27 equal to the increase in the Consumer Price Index or three percent (3%), whichever is less, over
28 the previous term, subject to confirmation by County Council; and

30 WHEREAS, this Council has determined by reviewing all pertinent information that the
31 aforementioned professional service contract with Oriana House, Inc. is necessary and in the best
32 interest of the County of Summit;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that:

39 The award by the Board of Control of a professional service contract with Oriana House,
40 Inc. for community corrections services for a one-year term, from 1/1/17 through 12/31/17, in an
41 amount not to exceed \$5,921,097.39, with four options to renew for an additional one-year term,
42 with the cost of any renewal term to be equal to the increase in the Consumer Price Index or
43 three percent (3%), whichever is less, over the previous term, is hereby confirmed and the
44 County Executive is hereby authorized to execute such professional service contract.

48 This Resolution is hereby declared an emergency in the interest of the health, safety and
49 welfare of the citizens of the County of Summit, and for the further purpose of immediately
50 providing community corrections services effective 1/1/17.



16 121.22 of the Ohio Revised Code.


