SECTION 1

The County Executive is authorized to advertise for bids for a five-year full maintenance service contract for Heating, Ventilation and Air Conditioning ("HVAC") at the County Medical Examiner's Facility, located at 85 N. Summit St., Akron, Ohio 44308, in Council District 4, for an estimated total cost not to exceed \$87,000.00; and

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason that it authorizes the Executive to immediately advertise for bids for the five-year full maintenance service contract for HVAC at the Medical Examiner's Facility.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
