A Resolution confirming the award by the Board of Control of a professional service contract between the Legal Defenders Office of Summit County, Ohio, Inc. and the Summit County Public Defender Commission for legal defender services for indigents for the Commission, for the period 1/1/17 to 12/31/17, in an amount not to exceed \$559,400.00, for the Executive and the Summit County Public Defender Commission, and declaring an emergency.

WHEREAS, the County has formed the Summit County Public Defender Commission pursuant to Chapter 120 the Ohio Revised Code; and

WHEREAS, the Commission is responsible for providing legal defense services to certain indigent persons charged with the commission of crimes under the ORC, the Codified Ordinances of the County of Summit and various municipal ordinances within the boundaries of the County; and

WHEREAS, the Commission is authorized by Section 120.14 of the Ohio Revised Code to contract with a nonprofit organization to provide legal services to indigent persons; and

WHEREAS, the Commission wishes to contract with the Legal Defenders Office of Summit County, Ohio, Inc., a nonprofit corporation, to provide legal representation to indigent persons on behalf of the Commission from 1/1/17 to 12/31/17, for an amount not to exceed \$559,400.00; and

WHEREAS, the County Executive is required to execute the aforementioned contract, the cost of which will be paid out of funds appropriated by Council in Account No. 10003-2711-45501 pursuant to Resolution No. 2016-435; and

WHEREAS, the Board of Control, at its meeting held January 4, 2017, awarded a professional service contract between the Legal Defenders Office of Summit County, Inc. and the Summit County Public Defender Commission for legal defender services for indigents for the Commission, for the period 1/1/17 to 12/31/17, in an amount not to exceed \$559,400.00; and

WHEREAS, this County Council finds and determines, after reviewing all pertinent information, that the aforementioned contract with the Legal Defenders Office of Summit County, Ohio, Inc. is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of a professional service contract between the Legal Defenders Office of Summit County, Ohio, Inc. and the Summit County Public Defender Commission for legal defender services for indigents for the Commission, for the period 1/1/17 to 12/31/17, in an amount not to exceed \$559,400.00, is hereby confirmed and the Executive is hereby authorized to execute such professional service contract.
