7 **A Resolution appropriating funds from the County of Summit Alcohol, Drug Addiction**
8 **and Mental Health Services Board for the Psycho-Diagnostic Clinic, for the period of 1/1/17**
9 **through 6/30/17, in the amount of \$245,048.76, with no local cash match requirement, for**
10 **the Court of Common Pleas-General Division, and declaring an emergency.**

12 WHEREAS, the County of Summit Alcohol, Drug Addiction and Mental Health Services
13 Board (“ADM”) has certified that pass-through grant funds are available, primarily from the
14 Ohio Department of Mental Health, with additional funding from ADM, for the period of 1/1/17
15 through 6/30/17, in the amount of \$208,461.00, with no local cash match requirement; and

17 WHEREAS, additional court revenues in the amount of \$6,000.00, with no local cash
18 match requirement, are available along with the aforementioned 2017 grant award; and

19
20 WHEREAS, the County Court of Common Pleas-General Division has various carryover
21 funds totaling \$30,587.76; and

22
23 WHEREAS, the Psycho-Diagnostic Clinic is needed to provided court-ordered
24 evaluations in criminal cases, and the aforementioned monies will be used to reimburse the
25 Clinic for expenditures; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information
28 that it is necessary and in the best interest of the County of Summit to appropriate the
29 aforementioned funds for the period of 1/1/17 through 6/30/17, in the amount of \$245,048.76,
30 with no local cash match requirement;
