7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Cargill, Inc. for road salt for the 2017 snow and ice control season, under CUE pricing, in**
9 **an amount not to exceed \$700,000.00, for the Engineer, and declaring an emergency.**

11 WHEREAS, the Board of Control, at its meeting held January 25, 2017, awarded a
12 purchase contract to Cargill, Inc. for road salt for the 2017 snow and ice control season, under
13 CUE pricing, in an amount not to exceed \$700,000.00, subject to confirmation by County
14 Council; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
17 that the aforementioned purchase contract with Cargill Incorporated is necessary and in the best
18 interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

25 The award by the Board of Control of a purchase contract with Cargill, Inc. for road salt
26 for the 2017 snow and ice control season, under CUE pricing, in an amount not to exceed
27 \$700,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such
28 purchase contract.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide for road salt for the 2017 snow and ice control season.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.


