A Resolution authorizing the County Executive to execute a grant agreement with the Development Finance Authority of Summit County for a grant in an amount not to exceed \$177,000.00 for calendar year 2017, for the Executive's Department of Community and Economic Development, and declaring an emergency.
WHEREAS, the Development Finance Authority of Summit County ("DFA") plays a critical role in economic development and job creation within Summit County, and providing a grant to the DFA allows it to continue this important role in our community; and
WHEREAS, this Council previously adopted Resolution No. 2016-435, which, as part of the 2017 General Fund Budget, appropriated funds in Account No. 10003-1139-65111, in the amount of \$75,000.00, for a grant to the Development Finance Authority of Summit County; and
WHEREAS, the DFA is the owner of the real property at 47 N. Main St., Akron, OH 44308, which was renovated in part using proceeds of a State of Ohio R&D loan; and
WHEREAS, the DFA has requested the County's assistance with the repayment of the aforementioned State of Ohio R&D loan; and
WHEREAS, the County Executive desires to provide assistance to the DFA on the 2017 payments of the State of Ohio R&D loan in the amount of \$102,000.00, which amount was appropriated as part of the 2017 Operating Budget, in Account No. 30620-8301-80501 pursuant to Resolution No. 2016-435; and
WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to authorize the County Executive to execute a grant agreement with the DFA for a grant an amount not to exceed \$177,000.00;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute a grant agreement with the Development Finance Authority of Summit County for a grant in an amount not to exceed \$177,000.00 for calendar year 2017. Of the grant proceeds, \$102,000.00 shall be applied towards the repayment of the State of Ohio R&D Loan, the proceeds of which were used to renovate the property at 47 N. Main St., Akron, OH 44308, and \$75,000.00 shall be used for economic development and job creation in Summit County.

SECTION 2

This Resolution is hereby declared to be an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further reason that it is necessary to immediately provide for the payment of the aforementioned grant to the Development Finance Authority of Summit County for 2017.
