7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with Language Line Services, Inc., for over-the-phone interpreter services for**  
9 **non-English speaking clients, for the period of 3/1/17 to 2/28/18, under State Term Pricing,**  
10 **in an amount not to exceed \$185,000.00, for the Executive's Department of Job and Family**  
11 **Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting on January 25, 2017, awarded a  
14 professional service contract with Language Line Services, Inc., for over-the-phone interpreter  
15 services for non-English speaking clients, for the period of 3/1/17 to 2/28/18, under State Term  
16 Pricing, in an amount not to exceed \$185,000.00 subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information  
19 that the aforementioned professional service contract with Language Line Services, Inc., is  
20 necessary and is in the best interest of the County of Summit;

22 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
23 of Ohio, that:

27 The award by the Board of Control of a professional service contract with Language Line  
28 Services, Inc., for over-the-phone interpreter services for non-English speaking clients, for the  
29 period of 3/1/17 to 2/28/18, under State Term Pricing, in an amount not to exceed \$185,000.00,  
30 is hereby confirmed and the County Executive is hereby authorized to execute such professional  
31 service contract.

35 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
36 welfare of the citizens of the County of Summit, and for the further reason to immediately  
37 provide for interpreter services effective 3/1/17.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take  
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
43 effect and be in force at the earliest time provided by law.

47 It is found and determined that all formal actions of this Council concerning and relating  
48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
49 deliberations of this Council and of any of its committees that resulted in such formal action,

51 121.22 of the Ohio Revised Code.
