8 **A Resolution approving and authorizing a salary adjustment for classified non-bargaining**

11 WHEREAS, the County Prosecutor wishes to grant a salary adjustment for classified  
12 non-bargaining employee Meggan Jewel Lilly effective March 20, 2017; and

14 WHEREAS, because the salary adjustment for the aforementioned employee represents a  
15 pay increase under Section 169.07 of the Codified Ordinances of the County of Summit, County  
16 Council's approval is required; and

18 WHEREAS, the Director of the County Executive's Department of Human Resources  
19 will review the personnel action for the aforementioned salary adjustment as required by Section  
20 169.07(b) of the Codified Ordinances; and

22 WHEREAS, the salary adjustment will be submitted to the Director of the Executive's  
23 Department of Finance and Budget for the certification of availability of appropriated funds for  
24 the aforementioned salary adjustment as required by Section 169.07(c) of the Codified  
25 Ordinances; and

27 WHEREAS, this Council has determined, after reviewing all pertinent information, that it  
28 is necessary and in the best interest of the County of Summit to approve and authorize the  
29 Prosecutor to make the aforementioned salary adjustment effective March 20, 2017;
