RESOLUTION NO. 237-16

A RESOLUTION TO REQUEST THE COUNTY OF SUMMIT, PURSUANT TO CHAPTER 5553 OF THE OHIO REVISED CODE AND CHAPTER 125 OF THE CODIFIED ORDINANCES OF THE COUNTY OF SUMMIT, TO VACATE A PORTION OF CANFIELD ROAD AND TO ACCEPT AND DEDICATE THE RECONFIGURED PORTION

WHEREAS, in Y 2001 a portion of Canfield Road, a public thoroughfare located in the Township of Springfield, Summit County, State of Ohio, was reconfigured to facilitate traffic flow and that reconfiguration established the public thoroughfare now used by the traveling public which has been maintained by the Township for at least the past fifteen years; and

WHEREAS, in Y 2001 a portion of Canfield Road was abandoned by necessity when the above referenced road reconfiguration occurred and that abandoned portion of road is no longer utilized or needed by the traveling public; and

WHEREAS, it appears that the abandoned portion of Canfield Road was never formally vacated as a dedicated public road pursuant to Chapter 5553 of the Ohio Revised Code;

WHEREAS, it appears that the reconfigured portion of Canfield Road was never formally dedicated or accepted as a public thoroughfare;

Now, Therefore, Be it Resolved by the Board of Trustees of the Township of Springfield, County of Summit, State of Ohio;

SECTION 1. After consideration of all pertinent information this Board requests the County of Summit, pursuant to Chapter 5553 of the Ohio Revised Code and Chapter 125 of the Codified Ordinances of the County Summit to vacate that portion of Canfield Road which, due to reconfiguration of said road on or about Y 2001 is no longer used by the public as a public road; and

SECTION 2. After consideration of all pertinent information this Board request the County of Summit, pursuant to Chapter 5553 of the Ohio Revised Code accept that portion of Canfield Road reconfigured in or about Y 2001 and used by the public as public road be formally accepted and dedicated as a public road; and

SECTION 3. Surveyors copies of pre Y 2001 Canfield Road along with the reconfigurations to the road system done at that time are attached as Exhibits "A", "B", "C" and "D" setting forth the general route, termini and portion of the road which is requested to be vacated being 1.3708 acres of land;

SECTION 4. The Surveyors copies of the road configurations made on or about Y 2001 to Canfield Road are also attached as Exhibits "A", "B", "C" and "D" which set forth the general route, termini and portion of the road requested to be accepted as dedicated public roads being 1.4494 acres of land.

This resolution is hereby declared to have been adopted by the Board of Trustees of the Township of Springfield, County of Summit, State of Ohio, at a public meeting, called and held on the 8th day of September, 2016.


