7 **A Resolution authorizing the County Executive to execute agreements for the acquisition of**  
8 **drainage easements for the Albrecht Road Culvert Replacement Project, located in**  
9 **Springfield Township, for a total amount not to exceed \$600.00, for the Engineer, and**  
10 **declaring an emergency.**

11  
12 WHEREAS, it is necessary to replace a box culvert on Albrecht Road in Springfield  
13 Township, in Council District 8, and place rock channel protection in roadside ditches to prevent  
14 erosion (the "Project"); and

15  
16 WHEREAS, drainage easements are required for the Project; and

17  
18 WHEREAS, the acquisition of the drainage easements is considered a "local cost" which  
19 must be borne in whole by the local public agency performing a project, in this case being the  
20 County of Summit; and

21  
22 WHEREAS, the acquisition of said drainage easements will allow the Project to proceed;  
23 and

25 WHEREAS, the drainage easements will be purchased from the owners for a total  
26 amount not to exceed \$600.00; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
29 that it is necessary and in the best interest of the County of Summit to authorize the County  
30 Executive to execute agreements for the acquisition of drainage easements for the Project, in  
31 Springfield Township, for a total amount not to exceed \$600.00;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
34 of Ohio, that;

38 The County Executive is hereby authorized to execute agreements of purchase for  
39 drainage easements for the Albrecht Road Culvert Replacement Project, in Springfield  
40 Township, in Council District 8, pursuant to which said owners of the properties subject to said  
41 drainage easements will be paid a total amount not to exceed \$600.00, as follows:

8 immediately allow a necessary project, the Albrecht Road Culvert Replacement Project, in

14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
15 effect and be in force at the earliest time provided by law.
