7 **A Resolution decreasing appropriations for the mental health services grant to the Court of**
8 **Common Pleas-Juvenile Division from the County of Summit Alcohol, Drug Addiction and**
9 **Mental Health Services Board for 2017, for the Executive’s Department of Finance and**
10 **Budget, and declaring an emergency.**

12 WHEREAS, this Council previously adopted Resolution No. 2017-032, which
13 appropriated funds, in the amount of \$11,397,700.50, in carryover balances for various grants for
14 2017; and

16 WHEREAS, it is necessary to reduce appropriations for the mental health services grant
17 to the Court of Common Pleas-Juvenile Division from the County of Summit Alcohol, Drug
18 Addiction and Mental Health Services Board to correctly state the carryover balance for 2017;

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that it is necessary and in the best interest of the County of Summit to reduce the aforementioned
23 appropriations for the aforementioned reason;

24 121.22 of the Ohio Revised Code.


