7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Euthenics, Inc. for bridge condition inspection engineering services for the**
9 **North Main Street Bridge over the Cuyahoga River in the City of Akron, also known as the**
10 **High Level Bridge, for a one-year period, with three options to renew for an additional**
11 **one-year period, in an amount not to exceed \$59,078.25, for the Engineer, and declaring an**
12 **emergency.**

14 WHEREAS, the Board of Control, at its meeting held March 22, 2017, awarded a
15 professional service contract with Euthenics, Inc. for bridge condition inspection engineering
16 services for the North Main Street Bridge over the Cuyahoga River (Bridge No. AKR-008-
17 0908), also known as the High Level Bridge, in the City of Akron, in Council District 2, for a
18 one-year period, with three options to renew for an additional one-year period, in an amount not
19 to exceed \$59,078.25, subject to confirmation by County Council; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that the aforementioned professional service contract with Euthenics, Inc. is necessary and in the
23 best interest of the County of Summit;

30 The award by the Board of Control of a professional service contract with Euthenics, Inc.
31 for bridge condition inspection engineering services for the North Main Street Bridge over the
32 Cuyahoga River (Bridge No. AKR-008-0908), also known as the High Level Bridge, in the City
33 of Akron, in Council District 2, for a one-year period, with three options to renew for an
34 additional one-year period, in an amount not to exceed \$59,078.25, is hereby confirmed and the
35 County Executive is hereby authorized to execute such contract.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and
40 welfare of the citizens of the County of Summit, and for the further reason to immediately
41 provide for bridge inspection engineering services of the High Level Bridge in 2017.

46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
47 effect and be in force at the earliest time provided by law.
