7 **A Resolution rescinding Resolution No. 2017-068, for the Executive's Department of Law,**  
8 **Insurance and Risk Management-Division of Public Safety-Emergency Management**  
9 **Agency, and declaring an emergency.**

10  
11 WHEREAS, County Council previously adopted Resolution No. 2017-068, which  
12 confirmed an award by the Board of Control of a purchase contract with EMS Innovations, Inc.  
13 for one twenty bed mobile hospital with one trailer for equipment storage and transport, in an  
14 amount not to exceed \$185,565.50; and

15  
16 WHEREAS, Section VIII of the bid requirements, regarding bidder qualifications, states  
17 that the vendor must provide evidence to the County's satisfaction of its financial ability to  
18 perform the work to its completion in accordance with the specifications, and/or supply the  
19 required commodity; and

20  
21 WHEREAS, the County has received information from EMS Innovations, Inc.'s lender  
22 that EMS Innovations, Inc. cannot meet the aforementioned requirements; and

23  
24 WHEREAS, at its March 22, 2017 meeting, the Board of Control adopted Directive No.  
25 068-17, which rescinded Directive No. 033-17 that awarded the aforementioned purchase  
26 contract to EMS Innovations, Inc. and rejected all bids submitted for said contract pursuant to  
27 Section 177.02(b) of the Codified Ordinances of the County of Summit; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
30 that it is necessary and in the best interest of the County of Summit to rescind Resolution No.  
31 2017-068 for the aforementioned reason;

33 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,  
34 State of Ohio, that:

38 Resolution No. 2017-068 is hereby rescinded in its entirety.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and  
43 welfare of the citizens of the County of Summit and for the further purpose of immediately  
44 rescinding Resolution No. 2017-068 to allow an immediate rebid of a necessary contract for one  
45 twenty bed mobile hospital with one trailer for equipment storage and transport.

49 Provided this Resolution receives the affirmative vote of eight members, it shall take  
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
51 effect and be in force at the earliest time provided by law.
