13 performance and pay equity, effective 4/17/17; and

15 WHEREAS, because the salary adjustments for the aforementioned employees represent
16 pay increases under Section 169.07 of the Codified Ordinances of the County of Summit, County
17 Council's approval of the salary adjustments is required; and

19 WHEREAS, the Director of the County Executive's Department of Human Resources
20 will review the personnel actions for the aforementioned salary adjustments as required by
21 Section 169.07(b) of the Codified Ordinances; and

23 WHEREAS, the salary adjustments will be submitted to the Director of the Executive's
24 Department of Finance and Budget for certification of availability of appropriated funds, as
25 required by Section 169.07(b) of the Codified Ordinances; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that is necessary and in the best interest of the County of Summit to approve and authorize the
29 Sheriff to make the aforementioned salary adjustments effective April 17, 2017;
