A Resolution appropriating an additional award from the State of Ohio Department of Rehabilitation and Correction, through the Community Based Correctional Facility subsidy grant program for State Fiscal Year 2017, for the period of 7/1/16 through 6/30/17, in an amount not to exceed \$40,000.00, with no local cash match requirement, and authorizing the County Executive to execute an amendment to the grant agreement with Oriana House, Inc., and the County of Summit Facility Governing Board to include the increase of \$40,000.00 for the operation of the Community Based Correctional Facility, for the Executive's Department of Law, Insurance and Risk Management-Division of Public Safety, and declaring an emergency.

WHEREAS, the State of Ohio Department of Rehabilitation and Correction ("ODRC"), through the Community Based Correctional Facility ("CBCF") subsidy grant program, previously renewed the award to the County of Summit for State Fiscal Year 2017, for the period of 7/1/16 through 6/30/17, in a total amount not to exceed \$5,452,456.00, with no local cash match requirement, for the operation of a community based correctional facility; and

WHEREAS, the ODRC has awarded the County of Summit an additional \$40,000.00 in funding through the CBCF subsidy grant program, for a total award of \$5,492,456.00; and

WHEREAS, the County of Summit Facility Governing Board, as the grant's statutory oversight committee, has selected Oriana House, Inc., as the vendor to continue the management of the County of Summit Community Based Correctional Facility's operations and to accept this additional funding; and

WHEREAS, the County of Summit will continue to be the fiscal agent for the grant program; and

WHEREAS, County Council previously adopted Resolution No. 2016-242, which appropriated the aforementioned CBCF subsidy grant program funds and authorized the County Executive to execute a one-year renewal grant agreement with Oriana House, Inc. and the County of Summit Facility Governing Board for the operation of the County of Summit's Community Based Correctional Facility for the period of 7/1/16 through 6/30/17; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to appropriate the additional CBCF subsidy grant funds, in an amount not to exceed \$40,000.00, with no local cash match requirement, for State Fiscal Year 2017, for the period of 7/1/16 through 6/30/17 and for the County Executive to execute an amendment to the grant agreement with Oriana House, Inc. and the County of Summit Facility Governing Board to include the increase, in an amount not to exceed \$40,000.00, for the operation of the County of Summit's Community Based Correctional Facility;
