7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Motorola Solutions, Inc., as a Best Practical Source, for ongoing connectivity**
9 **and maintenance for the upgrade of the 800 MHz Regional Radio System to the P-25**
10 **platform, for the period 1/1/17 through 12/31/17, in an amount not to exceed \$68,293.11,**
11 **and appropriating funds, for the Executive's Department of Law, Insurance and Risk**
12 **Management, Division of Public Safety, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held March 29, 2017, awarded a
15 professional service contract with Motorola Solutions, Inc., as a Best Practical Source, for
16 ongoing connectivity and maintenance for the upgrade of the 800 MHz Regional Radio System
17 to the P-25 platform, for the period 1/1/17 through 12/31/17, in an amount not to exceed
18 \$68,293.11, subject to confirmation by County Council; and

20 WHEREAS, it is necessary to appropriate funds for the aforementioned professional
21 service contract with Motorola Solutions, Inc.; and

23 WHEREAS, this Council finds and determines, by reviewing all pertinent information,
24 that it is necessary and in the best interest of the County of Summit to confirm the award by the
25 Board of Control of the aforementioned professional service contract with Motorola Solutions,
26 Inc. and to appropriate funds for said professional service contract; and
