7 **A Resolution authorizing the County Executive, pursuant to Section 177.17 of the Codified**
8 **Ordinances of the County of Summit, to solicit offers for the lease of space in the Summit**
9 **County Animal Control Facility for the purpose of providing dog and cat essential items at**
10 **the time of adoption, for the Executive's Department of Administrative Services, and**
11 **declaring an emergency.**

13 WHEREAS, Section 177.17 of the Codified Ordinances of the County of Summit
14 provides that upon the determination of the County Executive that any real property, including
15 land, buildings, public improvements or other improvements or any part thereof, owned by the
16 County is not necessary for County operations, the Executive shall submit to Council a proposed
17 resolution authorizing the Executive to solicit offers for the lease of the real property or any part
18 thereof, and to negotiate terms and conditions with any person or entity that submits an offer to
19 lease; and

21 WHEREAS, the Executive wishes to provide pet owners the option of purchasing dog
22 and cat essential items at the Animal Control Facility at the time of adoption of pets from said
23 facility; and

25 WHEREAS, the Executive wishes to solicit offers for the lease of space in the Summit
26 County Animal Control Facility, located at 150 Opportunity Parkway, Akron, Ohio 44307, in
27 Council District 5, for the purpose of providing the option to purchase dog and cat essential
28 items at the time of adoption and to negotiate terms and conditions with persons or entities
29 submitting an offer to lease said space for such purpose; and

31 WHEREAS this Council finds and determines, after reviewing all pertinent information,
32 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
33 solicit offers for the lease of space in the Summit County Animal Control Facility for the purpose
34 of providing the option of purchasing dog and cat essential items at the time of adoption and to
35 negotiate terms and conditions with persons or entities submitting an offer to lease said space for
36 such purpose;

38 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
39 of Ohio, that:

43 The County Executive is hereby authorized, pursuant to Section 177.17 of the Codified
44 Ordinance of the County of Summit to solicit offers for the lease of space in the Summit County
45 Animal Control Facility, located at 250 Opportunity Parkway, Akron, Ohio 44307, in Council
46 District 5, for the purpose of providing pet owners the option to purchase dog and cat essential
47 items at the time of adoption. The Executive is further authorized to negotiate terms and
48 conditions with persons or entities submitting an offer to lease said space for such purpose.

6 This Resolution is hereby declared an emergency in the interest of the health, safety and
7 welfare of the citizens of the County of Summit, and for the further reason that it necessary to
8 immediately solicit offers for the lease of space in the Summit County Animal Control Facility
9 for the purpose of immediately providing the pet owners the option to purchase these essential
10 items for pet ownership.

14 Provided this Resolution receives the affirmative vote of eight members, it shall take
15 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
16 effect and be in force at the earliest time provided by law.

21 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
