7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award from the Ohio Department of Job and Family Services of a Federal Fiscal**
9 **Year 2017 Ohio Youth Works program grant of Temporary Assistance for Needy Families**
10 **funds, for the period of 5/1/17 through 9/30/17, in the amount of \$447,190.00, with no local**
11 **cash match requirement, and appropriating these grant funds, for the Executive's**
12 **Department of Job and Family Services, and declaring an emergency.**

14 WHEREAS, the County Executive's Department of Job and Family Services ("SCJFS")
15 has received an award of Temporary Assistance for Needy Families funds ("TANF") funds from
16 the Ohio Department of Job and Family Services ("ODJFS") as a Federal Fiscal Year 2017 Ohio
17 Youth Works program grant, in the amount of \$447,190.00, with no local cash match
18 requirement; and

20 WHEREAS, this TANF funding will enable SCDJFS to serve youth ages 14 and 15
21 during the 2017 summer youth program, which will allow low income TANF-eligible youth to
22 gain valuable work experience while earning a paycheck; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County of Summit to authorize the County
26 Executive to execute any documents necessary to accept the award of the aforementioned
27 Federal Fiscal Year 2017 Ohio Youth Works program grant of TANF funds, for the period of
28 5/1/17 through 9/30/17, in the amount of \$447,190.00, with no local cash match requirement,
29 and to appropriate these grant funds for the aforementioned reason;
