7 **A Resolution approving and authorizing a salary adjustment for classified non-bargaining**

10 WHEREAS, the County Prosecutor wishes to grant a salary adjustment for classified  
11 non-bargaining employee Robin Reed effective May 29, 2017; and

13 WHEREAS, because the salary adjustment for the aforementioned employee represents a  
14 pay increase under Section 169.07 of the Codified Ordinances of the County of Summit, County  
15 Council's approval is required; and

17 WHEREAS, the Director of the County Executive's Department of Human Resources  
18 will review the personnel action for the aforementioned salary adjustment as required by Section  
19 169.07(b) of the Codified Ordinances; and

21 WHEREAS, the salary adjustment will be submitted to the Director of the Executive's  
22 Department of Finance and Budget for the certification of availability of appropriated funds for  
23 the aforementioned salary adjustment as required by Section 169.07(c) of the Codified  
24 Ordinances; and

26 WHEREAS, this Council has determined, after reviewing all pertinent information, that it  
27 is necessary and in the best interest of the County of Summit to approve and authorize the  
28 Prosecutor to make the aforementioned salary adjustment effective May 29, 2017;
