7 **A Resolution confirming an award by the Board of Control of a construction contract with**
8 **Blackhorse Bridge Construction, Inc., for the Vanderhoof Road Bridge Replacement over**
9 **the Tuscarawas River, in an amount not to exceed \$743,812.45, for the Engineer, and**
10 **declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held April 26, 2017, awarded a
13 construction contract with Blackhorse Bridge Construction, Inc., for the Vanderhoof Road
14 Bridge Replacement over the Tuscarawas River, in an amount not to exceed \$743,812.45,
15 subject to confirmation by County Council; and

17 WHEREAS, Council finds and determines after reviewing all pertinent information that
18 the aforementioned construction contract with Blackhorse Bridge Construction, Inc., is necessary
19 and in the best interest of the County of Summit;

21 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

24 SECTION 1

26 The award by the Board of Control of a construction contract with Blackhorse Bridge
27 Construction, Inc. for the Vanderhoof Road Bridge Replacement over the Tuscarawas River, in
28 an amount not to exceed \$743,812.45, is hereby confirmed and the County Executive is hereby
29 authorized to execute such construction contract.

31 SECTION 2

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide for a necessary construction contract for the Vanderhoof Road Bridge Replacement over
36 the Tuscarawas River in order for the project to proceed.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,

50 121.22 of the Ohio Revised Code.


