WHEREAS, Council finds and determines after reviewing all pertinent information that the aforementioned construction contract with Blackhorse Bridge Construction, Inc., is necessary and in the best interest of the County of Summit;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

DESCRIPTION NO

The award by the Board of Control of a construction contract with Blackhorse Bridge Construction, Inc. for the Vanderhoof Road Bridge Replacement over the Tuscarawas River, in an amount not to exceed \$743,812.45, is hereby confirmed and the County Executive is hereby authorized to execute such construction contract.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason to immediately provide for a necessary construction contract for the Vanderhoof Road Bridge Replacement over the Tuscarawas River in order for the project to proceed.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
