12 WHEREAS, the Board of Control, at its meeting held April 26, 2017, awarded a purchase
13 contract with Ohio CAT, under State Term Pricing, for one detachable Trail Kind HDG Custom
14 Trailer, for use by the County Engineer's Office, for a total amount not to exceed \$57,913.20;

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the aforementioned purchase contract with Ohio CAT is necessary and in the best interest of
19 the County of Summit;

21 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a purchase contract with Ohio CAT, under state
27 term pricing, for one detachable Trail King HDG Custom Trailer, for use by the County
28 Engineer's Office, for a total amount not to exceed \$57,913.20, is hereby confirmed, and the
29 County Executive is authorized to execute said purchase contract and any necessary documents
30 related to said purchase contract.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason that the
36 aforementioned purchase contract with Ohio CAT is immediately necessary to provide needed
37 equipment for use by the Engineer's Office.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.


