7 **A Resolution authorizing the County Executive to advertise for bids for two Special Service**  
8 **or Police Pursuit CBRNE Response SUVs for Homeland Security Region 5 Bomb Squads,**  
9 **for an estimated total cost not to exceed \$70,000.00, for the Executive's Department of Law,**  
10 **Insurance and Risk Management-Division of Public Safety/Emergency Management**  
11 **Agency, and declaring an emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
14 requires this Council's authorization for the County Executive to advertise for bids; and

15  
16 WHEREAS, the County Executive wishes to advertise for bids for two Special Service or  
17 Police Pursuit chemical, biological, radiological, nuclear and explosive materials ("CBRNE")  
18 Response SUVs for Homeland Security Region 5 Bomb Squads, for an estimated total cost not to  
19 exceed \$70,000.00; and

21 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office;

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
25 that is necessary and in the best interest of the County of Summit to authorize the Executive to  
26 advertise for bids for the aforementioned SUVs for Homeland Security Region 5 Bomb Squads;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that;

33 The County Executive is authorized to advertise for bids for two Special Service or  
34 Police Pursuit chemical, biological, radiological, nuclear and explosive materials ("CBRNE")  
35 Response SUVs for Homeland Security Region 5 Bomb Squads, for an estimated total cost not to  
36 exceed \$70,000.00.

40 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
41 of the citizens of the County of Summit, and for the further reason that it authorizes the  
42 Executive to immediately advertise for bids for the aforementioned necessary vehicles for  
43 Homeland Security Region 5 Bomb Squads.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take  
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
49 effect and be in force at the earliest time provided by law.


