7 **A Resolution authorizing the County Executive to execute a subgrant agreement with the**
8 **Ohio Department of Job and Family Services for grants received by the County**
9 **Prosecutor's Child Support Enforcement Agency during State Fiscal Years 2018 and 2019,**
10 **the period 7/1/17 through 6/30/19, for the Prosecutor-Child Support Enforcement Agency,**
11 **and declaring an emergency.**

13 WHEREAS, Section 5101.21 of the Ohio Revised Code states that, commencing 7/1/17,
14 the Ohio Department of Job and Family Services ("ODJFS") may only make grants to counties
15 through subgrant agreements as described in that section; and

16
17 WHEREAS, in conformance with Section 5101.21, ODJFS has developed a standard
18 subgrant agreement to be executed by the commissioners of each county prior to receiving
19 ODJSF grant funds; and

20
21 WHEREAS, the County Prosecutor's Child Support Enforcement Agency ("CSEA") has
22 received from ODJFS the standard subgrant agreement for State Fiscal Years ("SFY") 2018 and
23 2019, the period 7/1/17 through 6/30/19, that sets forth the rights and responsibilities of both
24 ODJFS and CSEA in relation to any grant that is awarded for SFY 2018 and 2019; and

26 WHEREAS, CSEA anticipates receiving grant funds from the Ohio Department of Job
27 and Family Services for SFY 2018 and 2019; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary and in the best interest of the County of Summit to authorize the County
31 Executive to execute said subgrant agreement with ODJFS for SFY 2018 and 2019;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that:

36 SECTION 1

38 The County Executive is hereby authorized to execute a subgrant agreement with the
39 Ohio Department of Job and Family Services ("ODJFS") for grants received by the County
40 Prosecutor's Child Support Enforcement Agency ("CSEA") for State Fiscal Years ("SFY") 2018
41 and 2019, the period 7/1/17 through 6/30/19. The Executive is hereby authorized to execute said
42 subgrant agreement in substantially the form attached to this Resolution as Exhibit A.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and
47 welfare of the citizens of the County of Summit, and for the further reason that it is necessary to
48 immediately execute said subgrant agreement so that CSEA is eligible to be awarded grant funds
49 from ODJFS for SFY 2018 and 2019, the period 7/1/17 through 6/30/19.

8 effect and shall be in force at the earliest time provided by law.



16 121.22 of the Ohio Revised Code.


