7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **Montrose Ford, Inc., under CUE pricing, for seven vehicles, for use by the County Sheriff's**  
9 **employees, for a total amount not to exceed \$171,288.60, for the Sheriff, and declaring an**  
10 **emergency.**

12 WHEREAS, the Board of Control, at its meeting held May 3, 2017, awarded a purchase  
13 contract with Montrose Ford, Inc., under CUE pricing, for one 2017 Transit Van 10 Passenger-  
14 Marked, one 2017 Transit Van 12 Passenger-Marked, one 2018 Ford Fusion SE FWD-Marked,  
15 one 2018 Ford Fusion-Unmarked, one 2017 Ford Escape-Unmarked, one 2017 Ford Taurus-  
16 Unmarked, and one 2017 Chevrolet Traverse-Unmarked, for use by the County Sheriff's  
17 employees, for a total amount not to exceed \$171,288.60; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
20 that the aforementioned purchase contract with Montrose Ford, Inc. is necessary and in the best  
21 interest of the County of Summit;

23 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
24 of Ohio, that:

28 The award by the Board of Control of a purchase contract with Montrose Ford, Inc.,  
29 under CUE pricing, for one 2017 Transit Van 10 Passenger-Marked, one 2017 Transit Van 12  
30 Passenger-Marked, one 2018 Ford Fusion SE FWD-Marked, one 2018 Ford Fusion-Unmarked,  
31 one 2017 Ford Escape-Unmarked, one 2017 Ford Taurus-Unmarked, and one 2017 Chevrolet  
32 Traverse-Unmarked, for use by the County Sheriff's employees, for a total amount not to exceed  
33 \$171,288.60, is hereby confirmed, and the County Executive is authorized to execute said  
34 purchase contract and any necessary documents related to said purchase contract.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and  
39 welfare of the citizens of the County of Summit, and for the further reason that the  
40 aforementioned purchase contract with Montrose Ford, Inc. is immediately necessary to provide  
41 needed vehicles for use by the Sheriff.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take  
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
47 effect and be in force at the earliest time provided by law.
