A Resolution appropriating Fiscal Year 2017 Probation Improvement and Incentive Grant funds from the Ohio Department of Rehabilitation and Correction for the purpose of assisting probationers in reintegrating into the community, for the period of 7/1/16 through 6/30/17, in the amount of \$29,733.02, for the Court of Common Pleas-Adult Probation Department, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2015-368, which authorized the County Executive to execute any documents necessary to accept a Fiscal Year 2016 and 2017 Probation Improvement and Incentive Grant (“PIIG”) from the Ohio Department of Rehabilitation and Correction (“ODRC”) for the purpose of assisting probationers in reintegrating into the community, for the period of 7/1/15 through 6/30/17, in the amount of \$169,903.00, with no local cash match requirement, and appropriated funds;

WHEREAS, the County of Summit Court of Common Pleas-Adult Probation Department has received Fiscal Year 2017 PIIG funds from the ODRC for the purpose of providing programming for probationers in order to assist their successful reintegration into the community, for the period of 7/1/16 through 6/30/17, in the amount of \$29,733.02, which are part of the original \$169,903.00 award;

WHEREAS, it is necessary to appropriate these grant funds; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to appropriate the aforementioned grant funds;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
