7 **A Resolution authorizing the County Executive to execute a subgrant agreement with the**
8 **Ohio Department of Job and Family Services, the Ohio Department of Medicaid and the**
9 **Summit County Children Services Board for grants received by Summit County Children**
10 **Services during State Fiscal Years 2018 and 2019, for the period 7/1/17 through 6/30/19, for**
11 **Summit County Children Services, and declaring an emergency.**

13 WHEREAS, Section 5101.21 of the Ohio Revised Code states that, commencing 7/1/08,
14 the Ohio Department of Job and Family Services (“ODJFS”) may only make grants to counties
15 through subgrant agreements as described in that section; and

16
17 WHEREAS, in conformance with Section 5101.21 of the Ohio Revised Code, ODJFS
18 developed a standard subgrant agreement to be executed by the commissioners or in the case of a
19 charter county, the executive, of each county prior to receiving ODJFS grant funds; and

20
21 WHEREAS, effective with the term of the proposed subgrant agreement, the State has
22 determined it necessary to add the Ohio Department of Medicaid (“ODM”) to the agreement due
23 to the County’s receipt of funds from that agency; and

25 WHEREAS, Summit County Children Services (“SCCS”) has received from ODJFS and
26 ODM the standard subgrant agreement for State Fiscal Years (“SFY”) 2018 and 2019, for the
27 period 7/1/17 through 6/30/19, that sets forth the rights and responsibilities of ODJFS, ODM and
28 SCCS in relation to any grant that is awarded for SFY 2018 and 2019; and

30 WHEREAS, SCCS anticipates receiving grant funds from ODJFS for SFY 2018 and
31 2019; and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
34 that it is necessary and in the best interest of the County of Summit to authorize the County
35 Executive to execute the aforementioned subgrant agreement with ODJFS, ODM and the SCCS
36 Board for SFY 2018 and 2019;

38 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
39 of Ohio, that:

43 The County Executive is hereby authorized to execute a subgrant agreement with the
44 Ohio Department of Job and Family Services (“ODJFS”), the Ohio Department of Medicaid
45 (“ODM”) and the Summit County Children Services Board for grants received by Summit
46 County Children Services (“SCCS”) for State Fiscal Years (“SFY”) 2018 and 2019, for the
47 period 7/1/17 through 6/30/19. The Executive is hereby authorized to execute said subgrant
48 agreement in substantially the form attached to this Resolution as Exhibit A.

6 This Resolution is hereby declared an emergency in the interest of the health, safety, and
7 welfare of the citizens of the County of Summit and for the further reason that it is necessary to
8 immediately authorize the Executive to execute said subgrant agreement so that SCCS is eligible
9 to be awarded grant funds from ODJFS and ODM for SFY 2018 and 2019 effective 7/1/17.

13 Provided this Resolution received the affirmative vote of eight members, it shall take
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
15 effect and be in force at the earliest time provided by law.
