7 **A Resolution authorizing the County Executive to advertise for bids for the Courthouse**  
8 **Facade Repair Project, located at 209 S. High St., Akron, Ohio 44308, in Council District 4,**  
9 **for an estimated total cost not to exceed \$232,500.00, for the Executive's Department of**  
10 **Administrative Services-Physical Plants Division, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for the Courthouse  
16 Facade Repair Project, located at 209 S. High St., Akron, Ohio 44308, in Council District 4, for  
17 an estimated total cost not to exceed \$232,500.00; and

19 WHEREAS this Council finds and determines, after reviewing all pertinent information  
20 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
21 advertise for bids for the aforementioned Courthouse Facade Repair Project;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

28 The County Executive is authorized to advertise for bids for the Courthouse Facade  
29 Project, located at 209 S. High St., Akron, Ohio 44308, in Council District 4, for an estimated  
30 total cost not to exceed \$232,500.00.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and  
35 welfare of the citizens of the County of Summit, and for the further reason that it authorizes the  
36 Executive to immediately advertise for bids for the aforementioned Courthouse Facade Repair  
37 Project in order to improve the appearance of the Summit County Courthouse and Annex and  
38 prolong the service life of a County asset in a timely manner..

42 Provided this Resolution receives the affirmative vote of eight members, it shall take  
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
44 effect and be in force at the earliest time provided by law.


