11 WHEREAS, due to an increase in cases, the County Executive’s Department of the
12 Medical Examiner has experienced a significant increase in the cost of contract services
13 including outside toxicology services and the transportation of decedents, and is also completing
14 necessary information technology infrastructure updates, necessitating an increase of
15 appropriations, in the amount of \$50,000.00, in the Medical Examiner’s Lab Fund; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the aforementioned increase in appropriations is necessary and in the best interest of the
19 County of Summit;
