11 **period of 10/1/16 through 9/30/17, and appropriating funds, for the Prosecutor, and**
12 **declaring an emergency.**

14 WHEREAS, the County Prosecutor has received an award from the State of Ohio
15 Attorney General's Office of a Federal Fiscal Year ("FFY") 2017 Victims of Crime Act
16 ("VOCA") grant for the travel costs for victims attending court hearings or meetings, in the
17 amount of \$530.00, with a local cash match requirement of \$132.50 to be paid from the
18 Prosecutor-General Office General Fund, for the period of 10/1/16 through 9/30/17; and

23 that it is necessary and in the best interest of the County of Summit to authorize the County
