7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept the award from the State of Ohio Department of Rehabilitation and Correction,**  
9 **through the Community Corrections Act of a 408 grant for State Fiscal Year 2018, for the**  
10 **period 7/1/17 through 6/30/19, in the amount of \$826,813.00, with no local cash match**  
11 **requirement, and appropriating these grant funds, for the Executive's Department of Law,**  
12 **Insurance and Risk Management – Division of Public Safety, and declaring an emergency.**

14 WHEREAS, the State of Ohio Department of Rehabilitation and Correction ("ODRC"),  
15 through the Community Corrections Act ("CCA") grant program, has renewed the award to the  
16 County of Summit of a 408 grant for State Fiscal Year ("SFY") 2018, in the amount of  
17 \$826,813.00, with no local cash match requirement, for community corrections programs to be  
18 operated by the County Sheriff and Oriana House, Inc., for the period 7/1/17 through 6/30/19;

21 WHEREAS, it is necessary for the County Executive to execute any documents  
22 necessary to accept the aforementioned SFY 2018 CCA 408 grant award and to appropriate these  
23 grant funds; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
26 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
27 execute any documents necessary to accept the aforementioned SFY 2018 408 grant funds, in the  
28 amount of \$826,813.00, with no local cash match requirement, and to appropriate these grant  
29 funds;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

39 Year ("SFY") 2018, in the amount of \$826,813.00, with no local cash match requirement, for  
40 community corrections programs to be operated by the County Sheriff and Oriana House, Inc.,

25 acceptance of the SFY 2018 CCA 408 grant funds from the ODRC and immediately  
26 appropriating these grant funds for use during the grant period commencing 7/1/17.

31 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
32 effect and be in force at the earliest time provided by law.


