7 **A Resolution adjusting existing appropriations, in the amount of \$220,000.00, within the**
8 **2017 Summer Youth Employment Program grant, for the Executive's Department of Job**
9 **and Family Services, and declaring an emergency.**

11 WHEREAS, this Council previously adopted Resolution No. 2017-150, which authorized
12 the County Executive to execute any documents necessary to accept an award from the Ohio
13 Department of Job and Family Services of a Federal Fiscal Year 2017 Ohio Youth Works
14 program grant of Temporary Assistance for Needy Families funds, for the period of 5/1/17
15 through 9/30/17, in the amount of \$447,190.00, with no local cash match requirement, and
16 appropriated grant funds; and

18 WHEREAS, the Executive's Department of Human Resources employs supervisors to
19 provide enhanced oversight at youth worksites and assistance with timesheet collection/review
20 for submission for the 2017 Summer Youth Employment Program; and

22 WHEREAS, it is necessary to adjust existing appropriations, in the amount of
23 \$220,000.00, in order to meet the needs of the employment costs of the supervisors of the 2017
24 Summer Youth Employment Program; and

26 WHEREAS, this Council finds and determines after reviewing all pertinent information,
27 that the adjustment of existing appropriations, in the amount of \$220,000.00, is necessary and in
28 the best interest of the County of Summit;
