An amended Resolution approving and authorizing the County Executive to execute and submit the Community Development Block Grant and HOME Investment Partnership Program 2017 Action Plan to the U.S. Department of Housing and Urban Development for program year 2017 and authorizing the Executive to execute the 2017 Community Development Block Grant and HOME Investment Partnership Program contracts, for the Executive's Department of Community and Economic Development, and declaring an emergency.

WHEREAS, as a prerequisite for receiving Community Development Block Grant ("CDBG") and Home Investment Partnership Program ("HOME") funding for program year 2017, the County is required to submit a 2017 Action Plan to the U.S. Department of Housing and Urban Development ("HUD") by August 16, 2017; and

WHEREAS, the County of Summit has not yet been informed by HUD as to what CDBC funding it can anticipates receiving \$872,757.00 in CDBG funding and \$308,361 in HOMI funding to receive for the 2017 program year, but estimates an allocation of \$915,000 for CDBC and allocation \$300,000 for HOME; and

WHEREAS, the County Executive's Department of Community and Economic Development has an available carry-over balance within CDBG funds of \$241,705.00; and

WHEREAS, the County of Summit CDBG Review Committee has reviewed and approved the 2017 CDBG projects and recommended project funding for the activities set forth in <u>amended Exhibit A</u>; and

WHEREAS, the Department of Community and Economic Development has prepared the 2017 Action Plan for CDBG and HOME programs, which is due to HUD by August 16, 2017; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to approve and authorize the Executive to execute and submit the 2017 Action Plan for the CDBG and HOME projects to HUD and authorize the Executive to execute the 2017 CDBG and HOME contracts;
