7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Integrio Technologies, LLC, at State Term Pricing, for the purchase of one RadPro**
9 **SecurPass Full Body Security Screening System for use at the Summit County Jail, in an**
10 **amount not to exceed \$237,990.00, for the Sheriff, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held June 7, 2017, awarded a purchase
13 contract with Integrio Technologies, LLC, at State Term Pricing, for one RadPro Securpass Full
14 Body Security Screening System for use at the Summit County Jail, in an amount not to exceed
15 \$237,990.00, subject to confirmation by County Council; and

17 WHEREAS, Council finds and determines after reviewing all pertinent information that
18 the aforementioned purchase contract with Integrio Technologies, LLC is necessary and in the
19 best interest of the County of Summit;

21 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of a purchase contract with Integrio Technologies,
27 LLC, for the purchase of one RadPro SecurPass Full Body Security Screening System for use at
28 the Summit County Jail, at State Term Pricing, in an amount not to exceed \$237,990.00, is
29 hereby confirmed and the County Executive is hereby authorized to execute such purchase
30 contract.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide for the necessary security at the Summit County Jail.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,

50 121.22 of the Ohio Revised Code.




