7 **A Resolution authorizing the County Executive to execute a purchase contract with EMS**  
8 **Innovations, Inc., subject to the approval of the Board of Control, for one twenty bed**  
9 **mobile hospital with one trailer for equipment storage and transport, in an amount not to**  
10 **exceed \$182,093.50, for the Executive's Department of Law, Insurance and Risk**  
11 **Management-Emergency Management Agency, and declaring an emergency.**

13 WHEREAS, County Council previously adopted Resolution No. 2016-432, which  
14 authorized the County Executive to advertise for bids for one twenty bed mobile hospital with  
15 one trailer for equipment storage and transport, in an amount not to exceed \$210,339.31; and

16  
17 WHEREAS, after advertising for bids, the Executive has selected EMS Innovations, Inc.,  
18 as the lowest responsive and responsible bidder, to provide a one twenty bed mobile hospital  
19 with one trailer for equipment storage and transport, in an amount not to exceed \$182,093.50 and  
20 wishes to execute a purchase contract with EMS Innovations, Inc., subject to the approval of the  
21 Board of Control, concerning the same; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that it is necessary and in the best interest of the County of Summit to authorize the Executive  
25 the aforementioned purchase contract with EMS Innovations, Inc., subject to the approval of the  
26 Board of Control;

28 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that:

31 SECTION 1

33 The County Executive is hereby authorized to execute a purchase contract with EMS  
34 Innovations, Inc., subject to the approval of the Board of Control, for one twenty bed mobile  
35 hospital with one trailer for equipment storage and transport, in an amount not to exceed  
36 \$182,093.50.

38 SECTION 2

40 This Resolution is hereby declared an emergency in the interest of the health, safety and  
41 welfare of the citizens of the County of Summit, and for the further reason to immediately  
42 authorize the Executive to execute the aforementioned purchase contract for a necessary one  
43 twenty bed mobile hospital with one trailer for equipment storage and transport so that it may be  
44 purchased and put into operation as soon as possible.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take  
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
50 effect and be in force at the earliest time provided by law.


