7 **A Resolution authorizing the County Executive to execute a collective bargaining**
8 **agreement between Ohio Council 8 and Local 1229 of the American Federation of State,**
9 **County and Municipal Employees, AFL-CIO (Executive's Office), and the County**
10 **Executive, for the period 4/1/17 through 3/31/20, which authorizes a two and one-half**
11 **percent (2.5%) increase in pay in each of the three years of the agreement, for the**
12 **Executive's Department of Human Resources, and declaring an emergency.**

14 WHEREAS, a collective bargaining agreement has been reached between the County the
15 County Executive and Ohio Council 8 and Local 1229 of the American Federation of State,
16 County and Municipal Employees, AFL-CIO (Executive's Office), for the period 4/1/17 through
17 3/31/20, which authorizes a two and one-half percent (2.5%) increase in pay in each of the three
18 years of the agreement; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that is necessary and in the best interest of the County of Summit to authorize the Executive to
22 execute the aforementioned collective bargaining agreement;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
25 of Ohio, that:

29 The County Executive is hereby authorized to execute a collective bargaining agreement
30 between Ohio Council 8 and Local 1229 of the American Federation of State, County and
31 Municipal Employees, AFL-CIO (Executive's Office), and the County Executive, for the period
32 4/1/17 through 3/31/20, which authorizes a two and one-half percent (2.5%) increase in pay in
33 each of the three years of the agreement.

37 This Resolution is hereby declared an emergency in the interest of the health, safety, and
38 welfare of the citizens of the County of Summit and for the further purpose of immediately
39 providing a timely collective bargaining agreement between Ohio Council 9 and Local 1229 of
40 the American Federation of State, County and Municipal Employees, AFL-CIO (Executive's
41 Office), and the County Executive.
