7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept the award from the Ohio Department of Public Safety's Office of Criminal Justice**  
9 **Services, of a Drug Law Enforcement Fund grant, for the period 7/1/17 through 6/30/18, in**  
10 **the amount of \$249,999.88, with a 25% local cash match requirement of \$83,333.29, and**  
11 **appropriating funds, in the amount of \$333,333.17, for the Sheriff, and declaring an**  
12 **emergency.**

14 WHEREAS, the Ohio Department of Public Safety's Office of Criminal Justice Services,  
15 of a Drug Law Enforcement Fund ("ODPS-OCJS") has awarded the Sheriff's Office a Drug Law  
16 Enforcement Fund ("DLEF") grant, for the period 7/1/17 through 6/30/18, in the amount of  
17 \$249,999.88, with a 25% local cash match requirement of \$83,333.29, for a total amount of  
18 \$333,333.17; and

20 WHEREAS, this DLEF grant will fund a countywide drug unit task force which will  
21 specifically target the manufacture, distribution and acquisition of illegal drugs in Summit  
22 County; and

24 WHEREAS, the local cash match will be provided by funds from the Sheriff's Summit  
25 County Drug Unit checking account; and

26  
27 WHEREAS, it is necessary to appropriate funds, in the amount of \$333,333.17; and

29 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
30 necessary and in the best interest of the County of Summit to authorize the Executive to execute  
31 any documents necessary to accept the award of the aforementioned DLEF grant from the  
32 ODPS-OCJS, and to appropriate grant funds;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

42 through 6/30/18, in the amount of \$249,999.88, with a 25% local cash match requirement of  
43 \$83,333.29, for a total amount of \$333,333.17.
