7 **A Resolution authorizing the County Executive to advertise for bids for the Summit**
8 **County Probate Courtroom Renovation Project, located at 209 S. High St., Akron, Ohio**
9 **44308, in Council District 4, for an estimated total cost not to exceed \$149,700.00, for the**
10 **Executive's Department of Administrative Services-Physical Plants Division, and declaring**
11 **an emergency.**

13 WHEREAS, the courtroom in the County of Summit Court of Common Pleas-Probate
14 Division, located at 209 S. High St., Akron, Ohio 44308, in Council District 4, was last
15 renovated in the 1970s; and

17 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
18 requires this Council's authorization for the County Executive to advertise for bids; and

20 WHEREAS, the County Executive wishes to advertise for bids for the Summit County
21 Probate Courtroom Renovation Project (the "Project") to renovate the Probate Division's
22 courtroom, which will update the appearance of the courtroom and allow for the installation of
23 court technology, for an estimated total cost not to exceed \$149,700.00; and

25 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office;

28 WHEREAS this Council finds and determines, after reviewing all pertinent information
29 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
30 advertise for bids for the aforementioned Project;

37 The County Executive is authorized to advertise for bids for the Summit County Probate
38 Courtroom Renovation Project, located at 209 S. High St., Akron, Ohio 44308, in Council
39 District 4, for an estimated total cost not to exceed \$149,700.00.

43 This Resolution is hereby declared an emergency in the interest of the health, safety and
44 welfare of the citizens of the County of Summit, and for the further reason that it authorizes the
45 Executive to immediately advertise for bids for the aforementioned the Summit County Probate
46 Courtroom Renovation Project, in order to complete a necessary renovation of the courtroom of
47 the County of Summit Court of Common Pleas-Probate Division in a timely manner to update
48 the appearance of the courtroom and allow for the installation of court technology.




