7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept a grant from the County of Summit Alcohol, Drug Addiction & Mental Health**
9 **Services Board for juvenile detention behavioral health services, for the period of 7/1/17**
10 **through 6/30/18, in the amount of \$245,346.00, with no local cash match requirement, and**
11 **appropriating funds, in the amount of \$110,151.37, for the Court of Common Pleas-**
12 **Juvenile Division, and declaring an emergency.**

14 WHEREAS, the County of Summit Alcohol, Drug Addiction & Mental Health Services
15 Board has awarded the Court of Common Pleas-Juvenile Division a grant for juvenile detention
16 behavioral health services, for the period of 7/1/17 through 6/30/18, in the amount of
17 \$245,346.00, with no local cash match requirement; and

19 WHEREAS, there are \$135,194.63 in carryover grant funds available from the previous
20 grant year; and

22 WHEREAS, it is necessary to appropriate funds, in the amount of \$110,151.37; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County of Summit to authorize the County
26 Executive to execute any documents necessary to accept the award of the aforementioned grant
27 from the County of Summit Alcohol, Drug Addiction & Mental Health Services Board and to
28 appropriate funds, in the amount of \$110,151.37;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
