8 **A Resolution authorizing the County Executive to execute a one-year intergovernmental**
9 **agreement with the County of Summit Alcohol, Drug Addiction & Mental Health Services**
10 **Board for the County Sheriff's Office to provide non-Medicaid behavioral health services**
11 **through its Drug Abuse Resistance Education unit to the Board, for the period 7/1/17**
12 **through 6/30/18, for payment to the County in a total amount not to exceed \$86,900.00, for**
13 **the Sheriff, and declaring an emergency.**

14 WHEREAS, the County of Summit Alcohol, Drug Addiction & Mental Health Services
15 ("ADM") Board wishes to execute a one-year intergovernmental agreement with the County for
16 the County Sheriff's Office to provide non-Medicaid behavioral health services through its Drug
17 Abuse Resistance Education ("D.A.R.E.") unit to the ADM Board, for the period 7/1/17 through
18 6/30/18, for which the ADM Board has agreed to pay the County a total amount not to exceed
19 \$86,900.00 during the term of the agreement; and

21 WHEREAS, the County wishes to provide said services to the ADM Board through the
22 D.A.R.E. unit; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that the aforementioned intergovernmental agreement is necessary and in the best interest of the
26 County of Summit;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that;

31 SECTION 1

33 The County Executive is hereby authorized to execute a one-year intergovernmental
34 agreement with the County of Summit Alcohol, Drug Addiction & Mental Health Services
35 ("ADM") Board for the County Sheriff's Office to provide non-Medicaid behavioral health
36 services through its Drug Abuse Resistance Education unit to the ADM Board, for the period
37 7/1/17 through 6/30/18, for payment to the County in a total amount not to exceed \$86,900.00
38 during the term of the agreement. The County Executive is hereby authorized to execute the
39 intergovernmental agreement in substantially the form attached to this Resolution as Exhibit A.

43 This Resolution is hereby declared an emergency in the interest of the health, safety, and
44 welfare of the citizens of the County of Summit and for the further purpose of immediately
45 authorizing the Sheriff's Office to provide non-Medicaid behavioral health services through its
46 D.A.R.E. unit to the ADM Board in 2017 and 2018 commencing 7/1/17.


