7 **A Resolution authorizing the County Executive to advertise for bids for the operation of**  
8 **the Jail Inmate Commissary at the Summit County Jail, located at 205 E. Crosier St,**  
9 **Akron, Ohio 44311, in Council District 4, for the period of 11/15/17 through 11/14/18, with**  
10 **five options to renew for an additional one-year term, for the Sheriff, and declaring an**  
11 **emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
14 requires this Council's authorization for the County Executive to advertise for bids; and

15  
16 WHEREAS, the County Executive wishes to advertise for bids for the operation of the  
17 Jail Inmate Commissary at the Summit County Jail, located at 205 E. Crosier St, Akron, Ohio  
18 44311, in Council District 4, for the period of 11/15/17 through 11/14/18, with five options to  
19 renew for an additional one-year term, in order to obtain the highest possible commission rate;

22 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office;

25 WHEREAS this Council finds and determines, after reviewing all pertinent information  
26 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
27 advertise for bids for the operation of the Jail Inmate Commissary at the Summit County Jail;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
30 of Ohio, that:

32 SECTION 1

34 The County Executive is authorized to advertise for bids for the operation of the Jail  
35 Inmate Commissary at the Summit County Jail, located at 205 E. Crosier St, Akron, Ohio 44311,  
36 in Council District 4, for the period of 11/15/17 through 11/14/18, with five options to renew for  
37 an additional one-year term.

39 SECTION 2

41 This Resolution is hereby declared an emergency in the interest of the health, safety and  
42 welfare of the citizens of the County of Summit, and for the further reason that it authorizes the  
43 Executive to immediately advertise for bids for the operation of the Jail Inmate Commissary at  
44 the Summit County Jail, so that such services may be timely provided when the current  
45 professional service contract for said services expires on 11/14/17.

49 Provided this Resolution receives the affirmative vote of eight members, it shall take  
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
51 effect and be in force at the earliest time provided by law.


