7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with Child Guidance & Family Solutions to provide prevention and intervention**  
9 **services for preschool aged children, for a one-year term, for the period of 10/1/17 through**  
10 **9/30/18, in an amount not to exceed \$85,000.00, for the Executive's Department of Job and**  
11 **Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held August 2, 2017, awarded a  
14 professional service contract with Child Guidance & Family Solutions to provide prevention and  
15 intervention services for preschool aged children, for a one-year term, for the period of 10/1/17  
16 through 9/30/18, in an amount not to exceed \$85,000.00, subject to confirmation by County  
17 Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information  
20 that the aforementioned professional service contract with Child Guidance & Family Solutions is  
21 necessary and in the best interest of the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

28 The award by the Board of Control of a professional service contract with Child  
29 Guidance & Family Solutions to provide prevention and intervention services for preschool aged  
30 children, for a one-year term, for the period 10/1/17 through 9/30/18, in an amount not to exceed  
31 \$85,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such  
32 professional service contract.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and  
37 welfare of the citizens of the County of Summit, and for the further reason to immediately  
38 provide for prevention and intervention services for preschool aged children effective 10/1/17.

43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
