7 **A Resolution confirming an award by the Board of Control of Change Order No. 1 to a**
8 **professional service contract with Community Legal Aid Services, Inc. for additional legal**
9 **services, for a one-year term, for the period 10/1/16 through 9/30/17, in an amount not to**
10 **exceed \$50,000.00 (a cumulative increase of 38.17%), for a total amount not to exceed**
11 **\$181,000.00, for the Executive's Department of Job and Family Services, and declaring an**
12 **emergency.**

14 WHEREAS, County Council previously adopted Resolution No. 2016-303, which
15 confirmed an award by the Board of Control of a professional service contract with Community
16 Legal Aid Services, Inc. for legal services, for a one-year term, for the period 10/1/16 through
17 9/30/17, in an amount not to exceed \$131,000.00; and

19 WHEREAS, the Board of Control, at its meeting held August 2, 2017, awarded Change
20 Order No. 1 to the aforementioned professional service contract with Community Legal Aid
21 Services, Inc., for additional legal services, for a one-year term, for the period 10/1/16 through
22 9/30/17, in an amount not to exceed \$50,000.00 (a cumulative increase of 38.17%), for a total
23 amount not to exceed \$181,000.00, subject to confirmation by County Council; and

25 WHEREAS, this Council finds and determines after reviewing all pertinent information,
26 that the aforementioned Change Order No. 1 to said professional service contract with
27 Community Legal Aid Services, Inc. is necessary and in the best interest of the County of
28 Summit;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The award by the Board of Control of Change Order No. 1 to a professional service
36 contract with Community Legal Aid Services, Inc. for additional legal services, for a one-year
37 term, for the period 10/1/16 through 9/30/17, in an amount not to exceed \$50,000.00 (a
38 cumulative increase of 38.17%), for a total amount not to exceed \$181,000.00, is hereby
39 confirmed and the County Executive is hereby authorized to execute such change order and any
40 other necessary related documents, including, but not limited to, any necessary amendments to
41 the professional service contract.

45 This Resolution is hereby declared an emergency in the interest of the health, safety and
46 welfare of the citizens of the County of Summit, and for the further reason to immediately
47 provide for the aforementioned additional legal services by Community Legal Aid Service prior
48 to the expiration of the professional service contract on 9/30/17.
