8 **service contract with Thomson Reuters – West Publishing Corp., as a Best Practical**
9 **Source, for online legal research services for 70 attorney and 70 non-attorney users, for a**
10 **two-year term, in a total amount not to exceed ~~\$87,550.81~~ \$90,177.31 for the two-year term,**
11 **for the Prosecutor, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held August 9, 2017, awarded a
14 professional service contract with Thomson Reuters – West Publishing Corp., as a Best Practical
15 Source, for online legal research services for 70 attorney and 70 non-attorney users, for a two-
16 year term, in an amount not to exceed ~~\$43,128.48~~ \$44,422.32 for the first year, and an amount
17 not to exceed ~~\$44,422.33~~ \$45,754.99 for the second year, for a total amount not to exceed
18 ~~\$87,550.81~~ \$90,177.31 for the two-year term, subject to confirmation by County Council; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that the aforementioned professional service contract with Thomson Reuters – West Publishing
22 Corp. is necessary and in the best interest of the County of Summit;

29 The award by the Board of Control of a professional service contract with Thomson
30 Reuters – West Publishing Corp., as a Best Practical Source, for online legal research services
31 for 70 attorney and 70 non-attorney users, for a two-year term, in an amount not to exceed
32 ~~\$43,128.48~~ \$44,422.32 for the first year, and an amount not to exceed ~~\$44,422.33~~ \$45,754.99 for
33 the second year, for a total amount not to exceed ~~\$87,550.81~~ \$90,177.31 for the two-year term, is
34 hereby confirmed and the County Executive is hereby authorized to execute such professional
35 service contract.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and
40 welfare of the citizens of the County of Summit, and for the further reason to immediately
41 provide for online legal research services for the Prosecutor.

46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
