7 **A Resolution adjusting appropriations in the Juvenile Court's Helping Ohioans Move,**
8 **Expanding Choice grant fund, in the amount of \$100,000.00, for the Court of Common**
9 **Pleas-Juvenile Division, and declaring an emergency.**

11 WHEREAS, County Council previously adopted Resolution No. 2016-294, which
12 authorized the County Executive to execute any documents necessary to accept an award
13 from the Summit County Combined General Health District dba Summit County Public
14 Health of a Helping Ohioans Move, Expanding Choice ("HOME Choice") Grant, for the
15 period 7/1/16 through 6/30/17, in the amount of \$100,000.00, with no local cash match
16 requirement, and appropriated funds; and

18 WHEREAS, an adjustment of appropriations in the Court of Common Pleas-Juvenile
19 Division's HOME Choice grant fund, in the amount of \$100,000.00, is necessary so that
20 funds may be expended as the local cash match for current Behavioral Juvenile Justice
21 ("BHJJ"), Youth Reentry, Family Resource Center, Alcohol, Drug Addiction & Mental
22 Health Detention Mental Health Services and Victims of Crime Act ("VOCA") grants; and

24 WHEREAS, this Council has determined by reviewing all pertinent information that
25 it is necessary and in the best interest of the County of Summit to adjust appropriations in
26 the Juvenile Division's HOME Choice grant fund for the aforementioned reason.;
