7 **A Resolution adjusting existing appropriations, in the amount of \$18,000.00, in the Juvenile**
8 **Court's Federal Fiscal Year 2017 Victims of Crime Act grant, for Court of Common Pleas-**
9 **Juvenile Division, and declaring an emergency.**

11 WHEREAS, County Council previously adopted Resolution No. 2016-420, which
12 authorized the County Executive to execute any documents necessary to accept the award from
13 the State of Ohio Attorney General's Office of a Federal Fiscal Year 2017 Victims of Crime Act
14 ("VOCA") grant, in the amount of \$171,175.58, with a 25% local cash match requirement of
15 \$42,793.89, and a Federal Fiscal Year ("FFY") 2017 State Victims Assistance Act grant, in the
16 amount of \$3,286.10, with no local cash match requirement, both for the period of 10/1/16
17 through 9/30/17, and appropriated said grant funds; and

19 WHEREAS, the actual costs of salaries related to the VOCA grant were underestimated
20 by \$18,000.00; and

22 WHEREAS this Council finds and determines, after reviewing all pertinent information,
23 that increasing appropriations, in the amount of \$18,000.00, in the FFY 2017 VOCA grant is
24 necessary and in the best interest of the County of Summit;
