7 **A Resolution increasing appropriations, in the amount of \$20,000.00, in the Juvenile**
8 **Court's Family Drug Court Implementation grant, for Court of Common Pleas-Juvenile**
9 **Division, and declaring an emergency.**

11 WHEREAS, County Council previously adopted Resolution No. 2013-438, which
12 authorized the County Executive to execute any documents necessary to accept an award from
13 the U.S. Department of Justice, Office of Juvenile Justice and Delinquency Prevention of a
14 Family Drug Court Implementation Project grant for the Court of Common Pleas-Juvenile
15 Division, for the Fiscal Years 2014 through 2016, in the amount of \$538,363.00, with no local
16 cash match requirement, and appropriated said grant funds for the period of 10/1/13 through
17 9/30/16; and

18
19 WHEREAS, Council subsequently adopted Resolution No. 2016-319, which adjusted
20 existing appropriations, in the amount of \$32,892.17, within the Family Drug Court
21 Implementation Project (the "Project") in order to implement a one-year extension of the Project.
22 for the period 10/1/16 through 9/30/17; and

24 WHEREAS, the actual costs of the Project are \$558,363.00; and

25
26 WHEREAS, the Juvenile Court wishes to use Helping Ohioans Move, Expanding Choice
27 grant funds to make up for the \$20,000.00 shortfall; and

29 WHEREAS this Council finds and determines, after reviewing all pertinent information,
30 that increasing appropriations, in the amount of \$20,000.00, for the Project is necessary and in
31 the best interest of the County of Summit;

33 NOW THEREFORE, BE IT RESOLVED by the Council of the Summit, State of Ohio,
