7 **A Resolution increasing appropriations, in the amount of \$42,273.00, in the Juvenile**
8 **Court's Federal Fiscal Year 2017 Temporary Assistance for Needy Families grant for the**
9 **Juvenile Court's Family Resource Center, for Court of Common Pleas-Juvenile Division,**
10 **and declaring an emergency.**

12 WHEREAS, County Council previously adopted Resolution No. 2016-349, which
13 authorized the County Executive to execute any documents necessary to accept the award from
14 the County Executive's Department of Job and Family Services of a Federal Fiscal Year ("FFY")
15 2017 Temporary Assistance to Needy Families ("TANF") grant to the Court of Common Pleas-
16 Juvenile Division for its Family Resource Center, for the period 10/1/16 through 9/30/17, in the
17 amount of \$419,799.00, with no local cash match requirement, and appropriated said grant
18 funds; and

20 WHEREAS, the actual costs of the Family Resource Center are \$462,172.00; and

22 WHEREAS, the Summit County Department of Job and Family Services has awarded an
23 additional \$42,373.00 in Title XX/TANF for the remainder of FY 2017; and

25 WHEREAS this Council finds and determines, after reviewing all pertinent information,
26 that increasing appropriations, in the amount of \$42,273.00, in the FFY 2017 TANF grant for the
27 Family Resource Center is necessary and in the best interest of the County of Summit;
