7 **A Resolution increasing appropriations, in the amount of \$27,000.00, in the Juvenile**
 8 **Court's Federal Fiscal Year 2017 Temporary Assistance to Needy Families Title XX grant**
 9 **for the Juvenile Court's Guardian Ad Litem Services Program, for Court of Common**
 10 **Pleas-Juvenile Division, and declaring an emergency.**

 12 WHEREAS, County Council previously adopted Resolution No. 2016-350, which
 13 authorized the County Executive to execute any documents necessary to accept an award from
 14 the County Executive's Department of Job and Family Services of a Federal Fiscal Year ("FFY")
 15 2017 Temporary Assistance to Needy Families Title XX ("TANF Title XX") grant to the Court
 16 of Common Pleas-Juvenile Division for its Guardian Ad Litem ("GAL") Services Program, for
 17 the period of 10/1/16 to 9/30/17, in the amount of \$281,398.00, with no local cash match
 18 requirement, and appropriated said grant funds; and

20 WHEREAS, the actual costs of the GAL Services Program are \$308,398.00; and

22 WHEREAS, the Juvenile Court wishes to use Helping Ohioans Move, Expanding Choice
 23 grant funds to make up for the \$27,000.00 shortfall; and

25 WHEREAS this Council finds and determines, after reviewing all pertinent information,
 26 that increasing appropriations, in the amount of \$27,000.00, in the FFY 2017 TANF Title XX
 27 grant for the GAL Services Program is necessary and in the best interest of the County of
 28 Summit;


